At the beginning of the month, the Quarterly Reports for Title I and Title II Part A were completed and submitted to PDE.

The Title I survey for parents was revised and will be distributed to the parents of Title I students which will be returned to the Title I teachers. Surveys will also be sent to the Title I staff to distribute to regular education classroom teachers so they can provide input on how the program has worked for the classroom teacher for the 17 - 18 school year. This will also provide them the opportunity to suggest changes for next year.
