Dear Parent(s)/Guardian(s):

East Allegheny will be administering the Pennsylvania System of School Assessments (PSSA) during the months of April and May for Remote students, as the U.S. Department of Education {USDE} recently announced that federal assessments will not be waived for the 2020-2021 school year.

Following that announcement, the Pennsylvania Department of Education {PDE} indicated that schools will have flexibility as to when testing may occur, and schools could delay until as late as September of 2021. The East Allegheny School District believes that testing students at the end of the school year, rather than over the summer or in the fall, provides our students with the best opportunity to be successful on their required exams.

We understand that the pandemic has created incredibly challenging circumstances for so many of our families, and we regret that high stakes testing during this time may add to the burden felt by our community. We acknowledge the exceptionally difficult conditions under which students will be testing, but we are required to adhere to state and federal mandates.

In an effort to support families who selected Remote for their child's education, we designed our testing schedule such that remote students will report to the building on Wednesdays. Students will participate in a morning test session and an afternoon test session. Between sessions, students will be provided with a lunch break.

Prior to testing, you will receive a survey regarding transportation and lunch options on the days of your child's testing as well as more in-depth examination information.

Please emphasize the importance of your child attending school during the days listed below and bringing their charged Chromebooks (and chargers), as testing will occur online. It is also very important that students are well rested and provided a healthy breakfast prior to testing. As a reminder, breakfast is available every day to all EA students at no cost
